Civil Documents - Travel

Civil documents must bear an original signature, stamp, and seal of the issuing office or registrar. Copies certified by

attorneys, Justice of the Peace, Notary Public, etc., are not acceptable. For any document not in English or in the official language of the country from which you are applying, a notarized translation is required in addition to the original.

Civil Documents for USA Immigrant Visa

(Nonimmigrant visa applicants do not routinely need to submit civil documents as part of their visa application.)

Immigrant visa and nonimmigrant visa applicants are required to submit or provide copies of certain civil documents as part of their visa application. These civil documents may include birth certificates, marriage certificates, and police records. If applying for an immigrant visa through a U.S. consulate abroad, applicants must send photocopies of all
